This title of thesis was "Teaching Speaking By Using Demonstration Method to Improve Students' Ability in Procedure Text to the Eighth Grade Students of SMP Negeri 1 Sungai Rotan". The limitation of the problem limited on "Teaching Speaking By Using Demonstration Method to Improve Students' Ability in Procedure Text to the Eighth Grade Students of SMP Negeri 1 Sungai Rotan". The formulation of the problem "Is there any significant effect of Using Demonstration Method Procedure Text in Teaching Speaking to the Eighth Grade Students of SMP Negeri 1 Sungai Rotan?". The objective of this study was "To find out whether there is any significant effect on the improvement of students' speaking ability after being taught by using demonstration method and without demonstration method". The population of this study was the eighth grade students of SMP Negeri 1 Sungai Rotan in the academic years 2021/2022 with the total 58 students as the samples, which were divided into two groups, they were experimental group and control group. The data were collected through test, pretest and post-test. The data were analyzed by using SPSS 22. The result of the experimental group showed that t-obtained was 17.444, which was at the 0.05 of level significance with degree of freedom (df) was 28 with the critical value 2.0484. Therefore it could be concluded that alternative hypothesis (Ha) was accepted and null hypothesis (Ho) was rejected, because t-obtained exceeded and higher than t-table p (.000) was less of lower than α (0.05). It means that there was significant difference between the students' scores in the pre-test and post-test, the scores improved highly. It meant that teaching speaking skills of the eighth grade students of SMP Negeri 1 Sungai Rotan by using demonstration method was effective.

CHAPTER 1

INTRODUCTION

This chapter outlines the following points of discussion: (1) background, (2) problem, (3) objective, (4) hypotheses

A. Background

Currently, the use of English is not only used as a lesson for communication between countries, but it also began to spread of various other fields, for example, the mass media. In this modern era, many mass media have used English in publishing news and other unique things. For this reason, as a nation that wanted to advance, the students must also be able to speak English so that if one day is needed, the students easily understood what the world wanted to convey.

According to Brown (2006), language is a complex, specialized skill, which develops in the child spontaneously, without conscious effort or formal instruction, is deployed without a warmness of its underlying logic, is qualitatively the same in every individual, and is distinct from more general abilities to process information or behave intelligently (p.16). Additionally, without experience in using the language, learners may tend to be nervous about trying to say things. This case brought a problem that made vocational schools have difficulties communicating in English.

Speaking is one of the language skills which is important for language students to be developed. According to Powers (2010), speaking is the basic

communication, so it is the most important skill among the other language skills (p.2). It meant that with English skills, communication became more fluent. More often you spoke in English, your skills were being honed and developed. Not only that but communicating also made it easier for you to got new friends.

According to Sriwilani (2010), in learning English through innovative and creative approaches, the process of learning speaking skills can be active, effective, and enjoyable (p.6). It meant that the demonstration method can meet this need. About learning English speaking skills, this method was very supportive of learning to express sentences related to suggestions and offers because everything related to the material that was being described in the activity procedure was more meaningful, not just memorizing, but understanding what was being done. Finally, the demonstration made students more active if done well by the teacher and students.

The study focuses on speaking because speaking is one of the skills in English that should be learned by the students. By speaking the students may allow themselves in interactive skills such as greeting, apologizing, thanking, asking, or offering something. If the students mastered speaking in English well, they had a good chance to express themselves in communication.

Based on the English curriculum of "Curriculum (2013 K-13)", speaking is taught based on a genre-based approach. Five texts should be learned by the students at a junior high school. The students are narrative text, report text, recount text, descriptive text, and procedure texts. One of the genres that must be learned by the students at junior high school is procedure text. In speaking

procedure text the students should use it with correct pronunciation, grammar, vocabulary, and fluency orally.

According to Yasin (2011), some factors that influence students' achievement in the teaching and learning process are teaching material, media, classroom activity, classroom management, teacher's approach, and teaching strategy (p.77). Based on the explanation before, in the researcher's opinion teaching English especially speaking by using demonstration method was be one of teaching aid in which students were given chance to learn English more fun and it was be hoped that it cloud motivate students to speak and pay attention to the material and it would create a fun learning English especially in procedure text because the students could explain orally about how the way to make something by using demonstration so they could motivate and create a fun teaching process.

In-state Junior High School 1 *Sungai Rotan* especially for the eighth-grade students class, the researcher found that the students had low motivation for English subject. Moreover, the researcher asked the teacher, and the teacher said when the teacher taught the students "the students" got low motivation in learning, and also when the teacher instructed by using English the students were not able to respond and caught the meaning of the teacher's instruction. It meant that this school had a problem with their speaking ability. From the problem above, the researcher concludes that:

- 1. Some of the students had low motivation in learning English
- 2. Some of the students were not able to get the instruction of the teacher
- 3. Some students were afraid to spoke English
- 4. Some students were still lack in vocabulary

Teachers have to have a new strategy in their teaching and learning activities. Erton (2012), states that there is a closed connection among the personality of the students, style, and strategy to make the students successful in academic performance (p.115). It meant that the teacher hoped to design a new strategy for their teaching and learning purposes, which was they had to observe the personality of their students, to increase teaching and learning achievement. So by using this method could improve students' speaking skills. From the description or experience above the researcher is interested to study the title of this study "Teaching Speaking by Using Demonstration Method to Improve Students' Ability in Procedure Text to the Eighth Grade Students of SMP Negeri 1 Sungai Rotan".

B. Problem of the Study

By doing this study, it was focus on teaching speaking by using the demonstration method in procedure text. The problem is limited and formulated below:

1. Limitation of the Study

The researcher needed to limit the problems of the study to focus on the topic. In this case, the researcher limited this study on "Teaching Speaking By Using Demonstration Method To Improve Students' Ability In Procedure Text To The Eighth Grade Students Of SMP Negeril Sungai Rotan".
